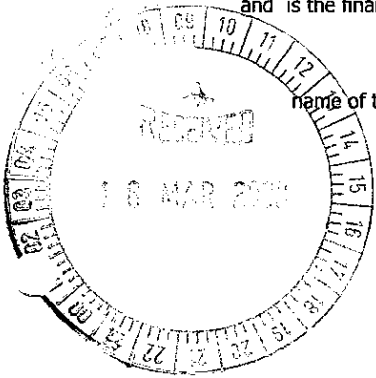

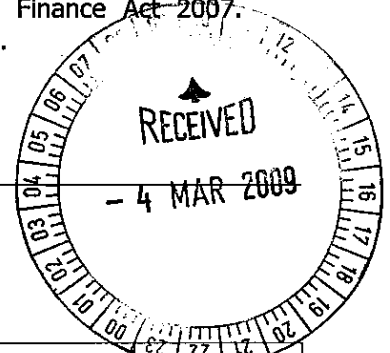
**Third party donation return – 2008 general election**
